INSTITUTIONAL PROFILE AND BACKGROUD

1) IRDP PROFILE

The Institute of Rural Development Planning (IRDP) is a government higher learning Institution under the Ministry of Finance. IRDP is a corporate body established by the Act of parliament No.8 of 1980. The Institute is registered by the National Council for Technical and Vocational Education and Training (NACTVET) and recognized by Tanzania Commission for Universities (TCU). In implementing one of its' core functions, IRDP offers and conduct Long Course Training on various multi-disciplinary and multi-sectorial areas, the courses aim to equip students with relevant, current and emerging practical knowledge and skills.

IRDP helps to enhance and strengthen the capacity for rural development practitioners by providing post-secondary education and training, research and consultancy services. IRDP is, thus, a multi-disciplinary and multi-sectoral institution empowered to oversee and coordinate the provision of expertise to in-service and pre-service personnel involved in Rural Development Planning and Management in the country.

Since its establishment in 1979, IRDP has been shaping destinies in planning and research methodologies focusing on the future prosperity of its students. As a result, graduates with IRDP qualifications have made valuable contributions in their fields. They are a proof of our unique approach of learning and training methodologies.

Over the recent years, the Institute has also made initiatives to improve its teaching, learning and working environment for both students and staff, by building state of art infrastructures and facilities.

2) IRDP LOCATION

IRDP Main Campus is located at Mbwanga area, which is about 7 kms from Dodoma City centre, along the Dodoma–Arusha Road. While IRDP Lake Zone Training Centre is located at Kitumba 'A' Village in Kisesa along Mwanza–Musoma Road.

3) IRDP VISION AND MISSION

3.1 Vision

The vision of IRDP is "to be a Centre of excellence in planning for sustainable development."

3.2 Mission

The mission of IRDP is "to provide quality training, research and consultancy services to public and private sectors through effective and efficient use of resources in planning for sustainable development with emphasis to rural areas."

4) IRDP LONG-TERM PROGRAMMES

Currently, IRDP offers a total of Sixty-One (61) distinct long-term academic programmes ranging from Certificate to Master degree levels. All the programmes are conducted using the Competence Based Education and Training (CBET) system, The CBET system is designed to ensure that upon graduation, the learner possesses the requisite competencies that can be applied flexibly in relevant work places. Competencies are generally associated with clear abilities to successfully carry out some occupational activities and is as described in terms of (1) knowledge, skills and understanding, (2) typical contexts and level that a person who possesses the competence could work in, and (3) wider attributes (conduct or attitude) reflecting change on actions.

The long-term academic programmes offered by IRDP with their respective entry qualifications (admission requirements) is as described in Table 1:

5) GENERAL ADMISSION GUIDELINES

The following are the admission guidelines that must be adhered to for a successful admission at the Institute.

- a) Application is done through Online Application System (**oas.irdp.ac.tz**) from the IRDP website **www.irdp.ac.tz**.
- b) Only the applicants who meet the minimum entry requirements may be selected.
- c) Selected candidates are required to report for an orientation program which normally takes place during the week preceding the beginning of the new academic year.
- d) Deadline for registration of first year students shall be two weeks from the first date of the orientation week while for continuing students it will be the Friday of the second week after the beginning of a semester.
- e) In addition, admission shall be granted to students only if they produce evidence of payment of at least half of the fee which is directly payable to the Institute.
- f) All students are required to conform entirely to Institute regulations and by-laws.
- g) Except in special circumstances, no student shall be allowed to change a program which he/she has been admitted to.
- h) No change of names by students will be entertained during the course of study and they will only be allowed to use names appearing on their form four academic certificate.
- i) No student will be allowed to postpone studies after commencement of an academic year except under special circumstances. Permission to postpone studies will be considered after producing satisfactory evidence of the reasons for postponement.
